15	ADMINISTRATIVE LAW - Local Government Creation and Function - The 1999 Constitution provides for the creation of the local governments and compels the State Governments to enact laws to ensure their existence, structure, composition, finance and function.
20	ADMINISTRATIVE LAW - Tiers of Government - functions of Local Government set out in the Constitution are not exhaustive and a State or Local Government may make laws expanding the functions of the Local Government; it is only where a function conferred on a Local Government by such law is inconsistent with a provision of the Constitution that it becomes null and void.
25	COMMERCE - Local Government - is empowered to establish, maintain and regulate slaughter houses, slaughter slabs, markets, motor parks and public conveniences.
30	INTERPRETATION - Literal Rule - Where words used in a statute are plain, simple and unambiguous, the literal rule of interpretation will be adopted. DEFINITION - "Include" - means to contain, comprise or embrace as a constituent part of a whole, or as subordinate element or to place in a class or category.
